COMPLAINT TRANSMITTAL COVERSHEET

Attached is a Complaint that has been filed against you with the Pakistan Office of Domain Name Dispute Resolution Centre (DNDRC) pursuant to the Uniform Domain Name Dispute Resolution Policy (the Policy) adopted by the Internet Corporation for Assigned Names and Numbers (ICANN) on October 24, 1999 and the PKNIC - Internet Domain Registration Policy.

The Policy and the PKNIC - Internet Domain Registration Policy is incorporated by reference into your Registration Agreement with the Registrar(s) of your domain name(s), in accordance with which you are required to submit to and participate in a mandatory administrative proceeding in the event that a third party (a Complainant) submits a Complaint to a dispute resolution service provider, such as the DNDRC, concerning a domain name that you have registered. You will find the name and contact details of the Complainant, as well as the domain name(s) that is/are the subject of the Complaint in the document that accompanies this Coversheet.

You have a duty to act at this time. The Pakistan Office of DNDRC has checked the Complaint to determine that it satisfies the formal requirements of the Policy, the PKNIC - Internet Domain Registration Policy, the Rules for Uniform Domain Name Dispute Resolution Policy (the Rules) and the DNDRC Supplemental Rules (if any) for Uniform Domain Name Dispute Resolution Policy (the Supplemental Rules), and it has received the required payment from the Complainant, this is an official forward a copy of the Complaint to you as the Notification of Commencement of Proceedings. You now have 7 calendar days within which to submit a Response to the Complaint in accordance with the Rules and Supplemental Rules to the DNDRC's Pakistan Office and the Complainant. Should you so desire, you may wish to seek the assistance of legal counsel to represent you in the administrative proceeding.
